### Hull

## P&I

- **Crew** – As a yacht owner, you are responsible for the care and safety of the crew you hire. Medical costs, sick pay, the costs of repatriating an injured crew member, hiring a replacement, as well as compensation costs arising from illness, permanent injury and death are all covered.
- **Guests** – As the owner of a yacht you are also responsible for the care and safety of guests you may have on board. This part covers medical costs as well as the costs of repatriating an injured guest. Compensation costs arising from illness, permanent injury and death are also covered.
- **Water sports** – Liabilities to a crew, guest or any other person caused by tenders, toys and diving equipment used in conjunction with your yacht are all covered. Cover can be extended to include submarines as well.
- **Airborne craft** – Claims caused by helicopters or other types of airborne craft while on board of your yacht are covered.

## Peace of mind

A newly acquired yacht, for example, is automatically covered and so is the pre-delivery crew when they are at the yard or port prior to the hand-over or delivery of your new yacht.
